The City of Victoria is pleased to offer a rebate program for the purchase and installation of a Smart Irrigation WaterSense labeled Controller as means of promoting water conservation! According to the *United States Environmental Protection Agency*, Residential outdoor water use in the United States accounts for more than 9 billion gallons of water each day, mainly for landscape irrigation. Replacing a standard clock timer with a Smart Irrigation WaterSense labeled controller can save an average home nearly 8,800 gallons of water annually. *Here's how the rebate process works:*

- *Replace your old inefficient irrigation controller with the Purchase and Installation of a new Smart Irrigation WaterSense labeled controller product.*
- *Complete this application form and attach a copy of the receipt (the receipt must be dated for the current year and clearly identify the purchase)*
- *Submit the application form to the City.*

The maximum rebate is \$300. **Limited funds are available.** Applications will be processed in the order they are received. This program is limited to residential customers that have a current utility account number with the City of Victoria.
